Alberto Pirni

Alberto Pirni is Associate Professor in Moral Philosophy at the Sant'Anna School of Advanced Studies – Institute of Law, Politics and Development, where he coordinates the research area in “Public Ethics”. He teaches “Public Ethics”, “Ethics and Economics”, “Ethics of Care Relationship”, “Ethics and Security”, and “Theories of Intergenerational Justice”. He has been Vice-President of the Joint Ethical Committee between SSSA and Scuola Normale Superiore.

Being the Sant'Anna School appointed as “Institutional Observer” for the UN Climate Change Conference (COP 26 – Glasgow, UK, 31 Oct. – 12. Nov. 2021), he has been member of the institutional delegation.

He spent research periods at the Universities of Tübingen and Freiburg i.Br. (Germany).

Visiting Professorships include the Universidad Autónoma and Universidad Complutense de Madrid, the Universität Vechta (Germany), the Saint Petersburg State University, Moskow School of Economics (Russian Federation), the Universidade Federal de Santa Catarina, Florianópolis (Brazil), Universidad Nacional de Rosario and Universidad de Buenos Aires (Argentine).

Main research fields involve: contemporary political and social philosophy; public ethics; ethics of technology; ethics and economics; theories of justice, climate justice, and energy ethics.

He is convenor of the Public Ethics International Seminars “Climate Change and Future Generations”, from March to December 2021 - within the programme “All4Climate – Italy 2021”, sponsored by the Italian Ministry for the Ecological Transition.

He is the author of 8 monographs, 2 collaborative volumes, and over 180 essays in volumes and refereed national and international journals (in 6 languages). He is also the editor and co-editor of more than 20 volumes and monographic issues of journals. Professor Pirni was the scientific coordinator of 4 research projects on topics of Public Ethics and 4 Erasmus+ Project. He also participated in 6 European research projects (FP7).

Finally, Alberto Pirni is Responsible Director of the International Journal “Lexicon of Public Ethics”
